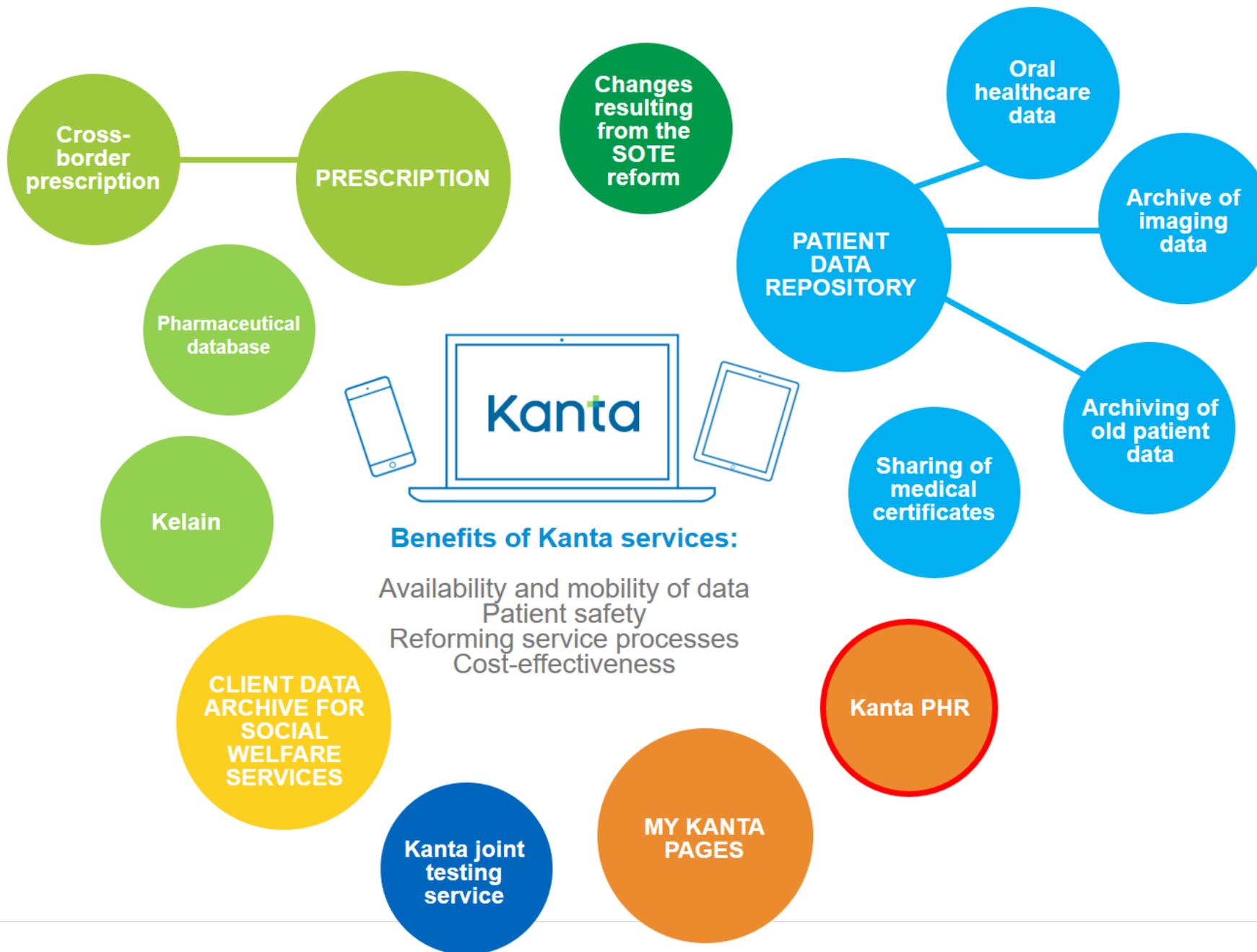

Kanta PHR

- Reliable national data repository for the citizen's own health and wellbeing data
- Use with wellbeing applications or in My Kanta Pages
- Persons have the right to decide on
 - recording and using their data
 - amending their data
 - deleting their data from Kanta PHR
- In the future, the Client Data Act will enable legislation whereby you can give your consent to sharing your wellbeing data with healthcare and social welfare professionals.

What kind of data

- The data that can be recorded includes
 - Measurements (e.g. blood pressure, blood glucose, calorie count and PEF)
 - Surveys (e.g. symptom assessments, health history forms and checkups)
 - Self-care plans
- National data content of the data repository
 - Open: anyone can propose what kind of data should be able to be saved in Kanta PHR
 - Based on the international [HL7 FHIR standard](#)

Wellbeing application

- Citizens can save and process their wellbeing data with applications, which can be used, e.g. on a computer with internet access or with mobile devices (smart phone, tablet)
- Made by any company / organisation / operator
- The application must be approved by the Kanta services
 - Approval criteria, demo, testing, information security audit and delivery terms

Citizens interested in wellbeing

-  **Start using** an online or mobile app to record your personal health and wellbeing data.
-  **Take measurements,** make assessments, complete surveys and carry out checks to promote your self-care and to receive instructions for any personal needs for care or support.
-  **Give your consent** to viewing your data and sharing it with social and health care professionals at omakanta.fi
-  **Browse** the data you have recorded at omakanta.fi
-  **Delete** your data if you so wish, or cancel your consent to use your personal data at omakanta.fi

Monitor your own wellbeing.

Take an active part in your care and share your own data with the professionals.
