

# MyHealth@EU

- MyHealth@EU is the existing infrastructure for **cross-border health services** that connects healthcare providers in 14 Member States
- Development started already in 2008
- Services includes exchange of PS, eP/eD, imaging studies and reports, test results and hospital discharge reports
- Evolution of MyHealth@EU for the EHDS
- Voluntary → mandatory







# Current governance of the eHealth Network




# EHDS – Overall timeline

# Xt-EHR - Introduction of the Joint Action

## Extended EHR@EU Data Space for Primary Use (Xt-EHR)

- **Joint Action** under the EU4Health Programme
- **Duration:** 30 months (01.11.2023 – 30.04.2026)
- **Consortium Setup:** 25 Partners, 25 Associated Entities and 8 Associated Partners in 26 European countries
- **Coordinator:** National eHealth Authority, Cyprus (NeHA)
- Finnish participants: THL and KELA

- Xt-EHR supports the European Commission's policy priority for '**A Europe fit for the digital age**' and aims to provide the necessary documentation to promote the adoption of **common specifications in EHR systems across Europe** based on the European EHR exchange format (EEHRxF).
- Xt-EHR aims to **establish requirements, guidelines, specifications, and implementation guides** to enhance the interoperability and exchange of healthcare data between EU Member States, in anticipation of the upcoming EHDS regulation.
- Xt-EHR provides the essential technical specifications that will be a major contribution into the most important **Implementing Acts**





# Targeted stakeholder engagement

- An early “informal” feedback of “closed” topic-related expert groups should be sought during the project and by the project partners.
- For the final deliverables / the implementing acts a formal consultation process will follow organized by the European Commission.
